## ACKNOWLEDGMENTS

It is a pleasure to acknowledge the remarkable competence of my three research assistants, Alfred Landau of the National Bureau of Economic Research, Walter Schiffer and Harry Chester of the Institute for Advanced Study, Princeton, New Jersey. All know the meaning of honest scholarship, and their assistance has stripped me of alibis for any of the shortcomings of this study.. I am grateful, too, for the secretarial assistance of Hattie Wise of the Institute for Advanced Study, and for the many hours of statistical computations performed by Jean Caplan and Edna Schisler.

It is also a pleasure to acknowledge the financial aid I have had during the preparation of this study. I am grateful to the Institute for Advanced Study for membership, to Wesleyan University for leave of absence, and to both those institutions and to the National Bureau of Economic Research for generous research grants, as well as to the John Simon Guggenheim Memorial Foundation for a Fellowship during 1941-43.

One of the very difficult problems encountered in this study was to estimate school and college enrollment by years and months. I could not have solved the problem without the help of the several hundred officials of public school systems and of colleges and universities who furnished me with statistics of school enrollment and attendance or with information about attendance practices and customs.

Another of the most difficult problems encountered was to estimate the population during 1914-23. At every stage in its solution I had the specialized counsel of Dudley Kirk and Frank Notestein of the Office of Population, Princeton University. In addition, I have found no branch of the government service more cooperative than the Census Bureau. Many courtesies have been extended me by J. C. Capt, Director; and especially by Philip M. Hauser, Assistant Director; Leon E. Truesdell, Chief Statistician for Population, A. Ross Eckler, Assistant Chief Statistician; Henry S. Shryock, Jr., General Population Statistics; John D. Durand, Employment Analyst. Nearly all of these officials have granted me numerous interviews and have written me long and patient letters to clear up my perplexities. Mr. Shryock aided me particularly in checking my annual population estimates against the newest Census revisions and Mr. Durand gave

me the benefit of the work he had done in reconciling the 1930 gainful worker figures with the 1940 labor force figures of the census. He may not recognize his help in the adjustments presented in Table 1, but I found it most valuable. Officials of other government agencies have my gratitude—Howard B. Myers and J. N. Webb, formerly of the WPA staff, who were chiefly responsible for initiating the Monthly Poll of the Labor Force and bringing it through its early life; and Loring Wood, formerly of the Bureau of Labor Statistics, who gave me and Mr. Chester very instructive interviews on the general problem of labor force and employment statistics.
