



CATERING CONTRACT

This Catering Contract is entered this January 10, 2019 by and between:

Carl Beck hereinafter referred to as the "CLIENT" and

The Food Dudes Inc. hereinafter referred to as the "CATERER"

Whereas the CLIENT will have an event described as follows:

Whereas the CATERER is a duly and registered licensed catering company and agrees to provide catering service for CLIENT'S above stated event.

Now therefore both parties bind themselves and agree as follows:

1. DEPOSIT

A 25% deposit in the amount of **\$3,083.85** is due upon signing this agreement to secure the date of the event. Your event date will be held for 14 days upon receiving this contract. If this contract is not signed and returned with a deposit within that time, your date will be released.

2. RENTALS

Kitchen and food service rentals are not included in this quote. A full list of rental equipment will follow upon confirmation of the menu and when coordination with venue is completed. An oven may be required if there is no access to one on site. Payment for rentals are to be made directly to the rental company.

3. GUEST COUNT

Final guest count for food and beverage is due 14 days prior to the event date. Any additional guests after the stated period may not be accommodated or may be subject to extra charges.

4. TIME

CLIENT will be billed for additional staffing hours based on changes in staffing needs and for any time extension beyond the prior agreed upon time.

5. LEFTOVERS

In accordance with appropriate Health Codes, the CATERER reserves the right to discard any leftover food items, after the agreed upon event timetable, where there is a reasonable risk for foodborne illness to occur.

6.2 Credit Card

Visa/MasterCard: A maximum of \$10,000.00 in total can be processed on credit cards. The remaining balance must be made through the other payment methods.

Amex: Generally not accepted. However, if it is the only option, an additional 4% processing fee will be applied on top of the final bill.

7. CANCELLATION

7.1 If the event is cancelled, three months (90 days) or more from the event date, the full deposit is returned to the CLIENT in full (less \$100.00).

7.2 If the event is cancelled, between 1 month (30 days) and 3 months (90 days) from the event date, the deposit is forfeited in full.

7.3 If the event is cancelled, within 2 weeks (14 days) to 1 month (30 days) of the event date, the CLIENT will be charged for 50% of their quote.

8. FINAL PAYMENT

Final payment is due 7 days prior to the event date, otherwise services will not be rendered.

Clients will be issued a post-event invoice after the event for any beverages on consumption and any additional staffing hours. Payment for the post-event invoice is due within 7 days of receiving the invoice. A service charge of 1% per week will be applied to all overdue accounts.
