#### Aim of the Research

The aim of this research project is to provide a significant contribution to the dynamics of measurement and ageing labour economics strategy in order to support better facts for policy formulation on evidence base accordingly, especially to support existing ageing labour productivity in Indonesia. It proposes, among others: a) Analysing the work readiness of the initial competencies of old age workers in the new normal era along with changes in dynamics, digitization and assessing the productivity level of old age workers; b) Analyse the determinants of the impact of the COVID-19 pandemic on the aging labour market in Indonesia; c) Analyse alternative labour market recovery strategies for older workers and their impact on the overall labour market in Indonesia; d) Analysis of ageing work ability index in Indonesia. The research also attempts to develop an appropriate instruments for measuring the productivity of the ageing labour force to the economy. The ageing labour productivity data will be very useful in supporting government's development planning, particularly for local economic development where Indonesia is undergoing transformation from a centralistic to a more local-friendly development planning. The research result expects could be an important role in supporting the new regulations of older person welfare in Indonesia.

Empirical gap: Only a few studies have studied the impact of Covid-19 and labor market recovery, especially in developing countries (e.g. Omar & Lennart, 2020; Acosta, 2020; Rio-Chanona, 2020; Cicih, 2020), not even specifically for older workers. So far, there have been no studies evaluating recovery policy efforts at individual employment rates by age group, particularly older workers in the Indonesian labor market. Also there has methodological gap and only a few studies were conducted at the individual level and type of work (e.g.: Dingel & Neiman 2020; Montenovo et al., 2020; Sostero el al., 2020). No studies have yet been conducted to outline the impact of Covid-19, digitalization, and globalization to evaluate relevant policy responses.

## Methodological gap:

The aftermath of the 1998 crisis had transformed the employment structure in Indonesia. The informal sector acted as a cushion to absorb workers from the formal sector who became unemployed as a result of the crisis. As a consequence, contrary to Rostow's growth theory where the formal sector is expanding and the informal sector shrinking, the reverse is true that some pundits warn of an impending deindustrialization process where the manufacturing sector is shrinking instead of expanding. A BPS data showed that in 1998 the economy and manufacturing sector shrunk by 13 percent (cited in Surbakti, 2005, p. 98). On the other hand, the informal sector increased substantially as a result of unemployed formal sector workers ending up in the informal sector (McGee and Firman, 2000). Workers in Indonesia could not afford to be unemployed because, unlike most developed countries, the Indonesian government does not sufficiently provide unemployment benefits to those who are not working. Thus, there is overcrowding of the informal sector and decrease in real wages due to increased competition in the informal sector (Bird and Manning, 2003). This phenomenon was not directly captured by any formal employment surveys, including those conducted by Statistics Indonesia.

The expansion of the informal sector is part of the global development of the labour force where employment has become more flexible. Flexibility of labour not only refers to flexible jobs such as part time employment, but also includes flexible time at work where workers only work and are paid on demand. This means that workers do not have job and income security because their work is based on fluctuations in demand for the products being produced (Standing, 1999). This is not to be confused with a flexible labour market. Egger and Sengenberger (2001) define labour market flexibility as lower cost and higher speed of adjustment in the labour market to changing conditions in the economic cycle. Oxfam International (2002) define as 'good' flexible labour market as a condition where it would be easier for workers to move from one job to another, as opposed to a 'bad' flexible labour market where employers can easily fire workers to make way for new ones. Flexibility of the workplace also creates flexible workers such as fixed term contract workers and outsourced workers. Information for these types of workers is not captured through the current SAKERNAS (the National Labour Force Survey) questionnaire. In Indonesia, there are indications that flexible workers are growing and becoming more and more a norm rather than the exception (Surbakti, 2005).

## Methodology

Design study: cross sectional study using mix method, both quantitative and qualitative study. Locations: in Indonesia. Data Sources: The data that will be used are primary and secondary data. The primary data collection will be conducted by quantitative and qualitative approach. The secondary data will be collected based on the desk study results and data analysis from various official institutions to support the results. Main sources will be collected from BPS Statistics Indonesia. Data Collections: The quantitative data will be collected by online surveys and virtual interviews. The online survey will be conducted to compile comprehensive information through sharing of the survey link directed to older person in Indonesia. In addition, we will select the two group of Focus Group Discussion (FGD).

#### Outcomes

This project will identify factors that directly and indirectly affect the ageing labour productivity due the changing of new norms and workplace. In further, provide an overview of prospective competencies in the new normal era to support the improvement of the relationship between old workers and the business world and their relation to labour market developments in urban and rural areas, gender equality and between generations. Strengthening empirical studies of the impact of COVID-19 on the labour market, especially in terms of changes in work location and productivity, reduced working hours, reduced wages, layoffs. Prepare recommendations for alternative policy strategies for the recovery of the old-age labour market and improvement of the capabilities and competencies of old-age workers in the new normal era.
