CALL FOR PAPER PROPOSALS

Social Insurance and Lifecycle Events Among Older Americans

With support from AARP, a conference on Social Insurance and Lifecycle Events Among Older Americans will be held on December 5th of 2014 in Washington, DC. The conference will focus specifically on lifecycle events commonly encountered by older Americans, the responsiveness of current policies to those events, and new thinking about policies consistent with a changing political environment. The conference will be organized into three sections dealing with the importance of changing career/job patterns, changes in family structure, and health limitations. Papers should focus on experiences and policies aimed at addressing Americans age 50 and older and highlight the experiences of different socio-economic groups, with a particular emphasis on the disadvantaged.

Funding is available for domestic travel to the conference for one author of each paper to be presented. It is anticipated that either a special issue of a scholarly journal or an edited volume will be produced based on papers delivered at the conference. Papers containing applied empirical analysis should focus on how existing policies address the focal issues of the conference. Authors are also encouraged to submit broader papers that focus on policy reform and recommendations. An outline of the draft conference agenda with suggested topical areas is detailed below. The organizers of the conference are Kenneth Couch (Professor, Department of Economics, University of Connecticut), Mary Daly (Senior Vice President and Associate Director of Research, Federal Reserve Bank of San Francisco), and Julie Zissimopoulos (Associate Director, Schaeffer Center for Health Policy and Economics, University of Southern California).
