Understanding the role of optimism in portfolio choices by Viola Angelini and Danilo Cavapozzi

Research proposal

Population ageing and increasing longevity imply that individuals must make careful and skilful use of financial resources, which should support their consumption over a much longer retirement period than a few decades ago. However, in Europe surprisingly large fraction of elderly households hold suboptimal portfolios and make a limited use of financial markets, which results in financial hardship in late life (Angelini et al, 2009).

This project investigates empirically how portfolio decisions of the elderly in Europe are affected by dispositional optimism and pessimism. Optimism is a potential source of overconfidence, which has been shown to lead to inefficient financial decisions (Odean, 1998). Using data from the US Survey of Consumer Finances, Puri and Robinson (2007) find that optimism has a positive and significant association with the participation in the equity market and on the amount of wealth invested in stocks. Our empirical analysis will be based on data from the Survey of Health, Ageing and Retirement in Europe (SHARE, <u>http://www.share-project.org/</u>), which collects information on the economic and non-economic conditions of individuals aged 50 in continental Europe. In particular, the SHARE questionnaire pays great attention to describe household portfolio investments, including bank accounts, bonds, stocks, mutual funds, individual retirement accounts, contractual savings for housing and life insurance policies. We will assess the role of dispositional optimism on the probability of holding risky and non-risky assets and on the amount of wealth invested in them.

At an empirical level, one of the key issues is how to measure dispositional optimism in the population. Puri and Robinson (2007) develop an indicator of dispositional optimism based on the difference between self-reported life-expectancy and that implied by actuarial life-tables. However, one problem with their analysis is that they do not explicitly control for cognitive skills, which might affect both life-expectancy miscalibration and investment behaviour. Then, some of the sample variability in the life-expectancy miscalibration index can be due to heterogeneity in cognitive functioning rather than to attitudes towards optimism.

In this project we will use an approach analogue to that of Puri and Robinson (2007) but explicitly controlling for cognitive skills using the indicators of numeracy, fluency and recall described by Christelis et al. (2010). The index of dispositional optimism will be calculated by combining actuarial survival probabilities released in the Human Mortality Database (HMD, <u>http://www.mortality.org</u>) with their subjective counterparts provided by SHARE respondents. An innovative aspect of our project is that we will validate our index of optimism by using the assessments that respondents give of anchoring vignettes, which are short descriptions of hypothetical persons described in particular situations or conditions and kept constant across respondents. Variability in vignette evaluations reflects individual heterogeneity in reporting styles (see for instance, Angelini et al., 2011 and 2013, and the references therein) and might turn out to be a valuable source of information to validate our measure of optimism. The idea is that more optimistic agents should rate the well-being of the hypothetical persons described in the vignettes more positively. Finding that better evaluations of the vignettes are associated with higher levels of our optimism index would support the hypothesis that the miscalibration in the probability of

survival actually describes individuals' attitudes towards optimism rather than more accurate forecasts of their life time horizons.

The results of this project will inform the economic literature about the importance of behavioural aspects in the portfolio decisions of the elderly. Optimism may induce a bias in investment behavior, challenging the rationality assumption of standard economic models and leading to inefficient portfolio allocations.
