Personality Traits and Financial Decision Making

Yilan Xu and Andrea H. Beller Department of Agricultural and Consumer Economics University of Illinois at Urbana-Champaign

Financial innovations broaden the choices available to households, but make financial decisions more difficult for the average individual. The low level of financial decision-making skills, financial literacy, and quality of financial education has drawn public attention, especially since the recent financial crisis (Lusardi, 2008; Gerardi et al., 2010; Hastings et al., 2012). One line of research focuses on the impact of cognitive ability on financial decision-making: for example, Agarwal and Mazumder (2013) find a negative correlation between math score and likelihood of poor financial decisions. Heckman et al. (e.g., 2012) draw attention to the importance of non-cognitive skills, as measured by personality traits. Using a unique dataset, we propose to examine their impact on financial decision-making. The findings may point toward a new way, such as early personality interventions, to address problems of over-indebtedness and other financial difficulties faced by U.S. households.

Psychologists have documented the predictivity of personality traits on several important life outcomes such as earning, health, schooling, and crime (Roberts et al., 2007; Duckworth et al., 2012; Hill et al., 2012; Judge et al., 2012). In addition, economists have found correlations between personality and wages, marriage, and fertility (Bowles et al., 2001; Lundberg, 2011; 2010). Recent efforts have been focused on identifying the causal impact of personality on outcomes (Cunha et al., 2010; Cunha and Heckman, 2008; 2007; Heckman et al., 2006; 2012); however, to our knowledge, our proposed study is the first attempt to identify the causality between personality and an extensive set of financial decision outcomes.

Nyhus and Webley (2001) document the correlations between household heads' personalities and households' saving and borrowing using data collected through CentER Saving Survey (CSS). We consider a wider range of outcomes, including debt-to-income ratios, unaffordable home mortgages, and missing bills, as proxies for unobservable financial literacy. Financial literacy, either self-assessed or measured by the fraction of correct answers on the "Big Five" literacy questions (Lusardi and Mitchell, 2011), has been shown to be correlated with a series of financial outcomes (Hastings et al., 2012).

Our analyses are carried out with the National Longitudinal Study of Adolescent Health (Add Health) data, which broadly surveys health, health behaviors, and their contexts from adolescence through young adulthood. To date, this data set has only infrequently been used by economists. Wave I (1994-95) sampled approximately 90,000 adolescents in grades 7–12 from primary sampling units of high-schools and their "feeder schools". A subsample of 20,745 participated in an in-home questionnaire. This subsample was reinterviewed in 1996, 2001-02, and 2007-08 (Waves II, III and IV, respectively). The 15,197 young adults in Wave IV were ages 24-32, a crucial time for initial major financial decisions, and Wave IV includes measures of several household finance outcomes. Both Waves I and IV include personality questionnaires. While Wave IV includes measures of the "Big Five" personality traits (i.e., extraversion, neuroticism, conscientiousness, agreeableness, and openness to experience), only measures of the first three can be constructed from the Wave I questionnaires (Young and Beaujean, 2011).

This unique data set can potentially identify the causal relationship between personality traits and financial decisions. We are aware of complications associated with identifying the impact of personality based on measurable personality traits, such as the intervention of cognition and incentive, reverse causality, and measurement errors of personality traits (Roberts et al., 2007; Heckman et al., 2006; Duckworth et al., 2012; Cunha and Heckman, 2008; Hill et al., 2012; Urzua, 2008; Judge et al., 2012; Borghans et al., 2011; 2008). Fortunately, our personality measures are not from achievement tests; thus, cognition and incentive are less likely to play a role in the personality measurements (Almlund et al., 2011). Nevertheless, we will account for individual cognition as well as constraints and incentives associated with financial decisions. Cognition will be measured by the math scores in grades 7-12 available for the subjects interviewed in Wave I; constraints and incentives for wise financial decisions will be proxied by household income. Since Add Health did not measure spouses' personality, individual decision-making power within the household must be controlled for (Nyhus and Webley, 2001). We will also address the other identification issues. First, we will use personality traits prior to the financial decisions as instrumental variables for personality traits at the time of the financial decisions (Groves, 2005; Feinstein, 2000). Although personality can be shaped gradually by life experiences, there is evidence that it is rank stable among young adults (Robins et al., 2002); therefore, the relevance condition of the instrumental variable is satisfied. Second, we will adapt the factor analysis method developed by Heckman et al. (2012) to account for the multi-dimensionality and measurement errors of personality measures.

There are several ways to introduce psychological variables into economic models (Bowles et al., 2001; Almlund et al., 2011; Ferguson et al., 2011). Our unique data also allow us to explore several potential mechanisms, such as risk preference, time preferences, social networks, and mental health. In particular, questionnaires about gambling and risk-taking were administered in Wave III, while indices of social psychology and mental health were constructed for Wave IV. Matching the individual's residential location to the local socioeconomic environment will permit construction of the social network background for an individual. Taking advantage of the rich information provided by Add Health can allow us to distinguish the avenue through which personality traits affect financial decisions.

Our work will contribute to the literature in several ways. It adds to the literature on the long-term effect of personality traits. The Add Health data set includes more personality measures than other longitudinal data, like the NLSY, where only measures of self-esteem and sense of mastery are available in multi-waves. Furthermore, the personality questionnaires included in Waves I and IV of Add Health enable us to take advantage of the stability of personality (Roberts et al., 2005) and to address the issue that individuals may fake their personality in surveys (Borghans et al., 2008). Finally, our study focuses on the financial decisions of young adults at critical ages for making their initial financial decisions. Once the causality is identified, our work can provide new insights into how to improve the efficiency of interventions on financial literacy and education.

The grant from NBER will be used for data processing and analysis. This work will lay the groundwork for further investigations and potential grant applications. A detailed budget with justifications is attached.

We are requesting \$17,016 in support for this project. About \$4366 will be used to pay a 50% time GRA during the summer to work on data development and analysis for the research. The purchase of the Add Health data including the geographic information will cost \$1500. One trip to Ann Arbor, MI to work with the restricted data on site will cost \$1500. About \$8000 will be used for two trips for each investigator to present the paper at the NBER workshop (presumably in Cambridge) and at the AEA meetings in Philadelphia and/or the American Council on Consumer Interests (ACCI) meetings. The remainder will be used to purchase an iPad (\$600), for submission and page fees (\$600), materials and supplies (\$250), and discretionary support (\$200).
