Project Goals.

A lack of capital on American Indian reservations has been identified as a key hindrance to economic development in Indian Country. Research on access to and usage of credit on reservations is scarce, largely due to lack of data. Our research draws on a unique large-scale individual-level consumer credit database, the Federal Reserve Bank of New York/Equifax Consumer Credit Panel (CCP), to explore the determinants of credit on American Indian reservations. We plan to document differences in credit usage patterns between individuals on reservations and those in nearby areas and examine possible legal and institutional causes of these differences. For example, by modifying existing models of credit or liquidity constraints, we will assess whether these constraints appear more or less binding on reservations. Similarly, we plan to explore the effects on credit usage of differences in tribal jurisdiction over civil and criminal cases (which varies among reservations due to PL280 and subsequent laws) and differences in the proximity of lenders (e.g., banks, credit unions, and community development financial institutions).

Data Requirements.

The Federal Reserve Bank of New York/Equifax Consumer Credit Panel (CCP) contains a 5% national sample of quarterly data on credit volume, delinquency status and other measures for a comprehensive set of consumer credit categories (mortgage, home equity, bankcards, retail finance, auto bank loans, auto finance loans, etc.) at the household level from 1999 to the present. Importantly, census block codes are for each record in the CCP. We plan to build a sample of households that live on and near Federal Indian reservations or off-reservation trust land. (We built a geographically similar sample with aggregated block-group level CCP data for an earlier project; this would be a household-level sample). Further we will match the household credit data to block and block-group level socio economic and demographic variables from the U.S. Census, bank location data from the FDIC, and several reservation-level variables that we plan to construct or

refine for this project including court jurisdiction, information on tribal courts such as capacity and performance measures, tribal government adoption of Uniform Commercial Codes(UCC) and subsequent implementation of secure transaction laws, and cultural characteristics.

Data Sharing.

Due to confidentiality agreements, we would not be able to share the credit data from the CCP. However, we could share other data. For example, the set of census blocks in or near to American Indian reservations along with geographic information such as distance to banks and, for blocks that are off-reservation, distance to nearest reservation could be valuable to other researchers interested in American Indian economic development. Also non-credit variables that we code and compile from public sources such as UCC adoption, jurisdiction, and tribal court capacity could be shared.

Background.

Our research focus on American Indian development has been fairly recent. We have one published paper on the effect of PL280, a 1953 law that shifted jurisdiction away from tribal and federal court to state courts on select Indian reservations, on income and crime in Indian Country (Dimitrova-Grajzl et al, 2014). We also have a working paper on patterns of credit usage on and near American Indian reservations (Dimitrova-Grajzl et al, 2014b). In the latter paper, we were restricted to analyzing credit data from the CCP aggregated to the census block-group level. The current project is aimed at more thoroughly exploring causal explanations of credit usage by exploiting access to the individual-level Consumer Credit Panel and the construction of additional institutional variables.

Proposed Budget

RADAR Terminal Access. The Federal Reserve Bank of Minneapolis has agreed to provide one of our project members, Joseph Guse, with a "Fed" computer for the purpose of using the restricted individual level data in the FRBNY/Equifax Consumer Credit Panel. The data is accessed through a RADAR (Risk Assessment Data Analysis and Research) terminal. The annual license for a RADAR terminal is \$3600. We are asking for two years.

Research Assistance. We would hire research assistants to help code several variables with the potential to influence credit markets in Indian Country. As mentioned above, this would include efforts to systemically capture (i) the extent of government or foundation development initiatives on reservations (e.g. CDFIs), (ii) tribal level adoption of Uniform Commercial Codes and related implementation of secure transaction systems, (iii) jurisdiction (e.g. tribal, state, federal), (iv) tribal court capacity and performance, (v) land status (e.g. trust vs. fee-simple) and (vi) cultural variation. \$3100 is the standard price for an undergraduate summer research assistant at Washington and Lee University. We are asking for two – one for 2014, one for 2015.
