# <u>DETERMINANTS TO FINACIAL CAPABILITY IN INDIA – AN INTER-REGIONAL AND INTER-GROUP ANALYSIS</u>

#### Introduction

Financial inclusion implies access to financial products at the affordable cost to all sections of the society. Financial inclusion is the process of "ensuring access to financial services and timely and adequate credit where needed by vulnerable groups such as the weaker sections and low income groups at an affordable cost" (Rangrajan committee 2008). Access to financial products at the affordable cost could well lead to improved standards of living of poor and disadvantaged and may also help in generating employment opportunities. Financial inclusion not only improves the financial position at individual level but also has larger economic implications including macro level financial stability. An improved financial inclusion can generate savings amongst the poor and disadvantaged that may have a multiplier effect on the economy. Increased level of saving could lead to the increased deposit base of banks and can stimulate investment. Moreover increased bank connection amongst the poor and disadvantaged population could well lead to greater transparency in the implementation of targeted schemes for rural housing, employment and crop insurance.

Despite the multifold benefits of financial inclusion, India lags much behind in ensuring financial inclusion. A large section of the adult population in India is still unbanked; overall 40 percent and a staggering 60 percent in rural areas (Thorat 2007). In India, only 35 percent have formal accounts versus an average of 41 per cent in developing economies (World Bank 2012). An immediate implication of this is that such population has greatly relied on costly informal financial sources, when they may have access to cheap financial products in the formal sector. The report further suggests that only 7.7 percent of the population aged 15 and above had taken loans from formal financial institutions. On the other side 26 percent took loan from informal sources including private lenders, family and friends. The major reason for this could be lack of financial literacy amongst the youth population in India. In a country like India, with a significant portion of the population being faced with financial resource constraint, lack of strong banking relationship exposes them to financial vulnerability. This situation indicates towards a paradox that financial inclusion is not sustainable in the absence of financial stability and financial stability is not sustainable when a significant portion of the population is financially excluded.

Financial education could play critical role in shaping the structure of financial inclusion. Financial education improves the knowledge and in turn positively affects the financial behavior of individuals (Bernanke, 2006; Lusardi and Mitchell, 2007; Martin, 2007). Absence of basic financial literacy can have far reaching consequences. This could typically lead to poor financial decision (Lusardi and Mitchell 2007) including borrowing decisions (Lusardi and Tufano 2009) which in turn can affect the standard of living (Cole, Sampson and Zia 2009). Financial capability is a function of both financial opportunity and financial education.

Therefore, it seems essential to investigate approaches adopted towards improving the financial capability of individuals and its relationship with financial inclusion in India. How far it has led to the financial inclusion of poor and disadvantaged sections of the society and what challenges exist defining and executing an effective policy to improve the Fiancial capability of literate youth. With this in mind the present research aims to investigate the following objectives;

- a. To develop conceptual understanding of financial capability in the Indian context.
- b. To develop a multivariate composite index of financial inclusion and financial capabilities.
- c. To assess the relationship between financial inclusion and financial capabilities.
- d. To develop a theoretical model of financial capabilities.
- e. To test the theoretical model to identify factors determining financial capabilities
- f. To understand the financial decision making amongst the youth population.
- g. To analyse how do the financial capabilities vary by subgroups of the population: caste, gender, income group?

# Methodology

This research will employ both primary and secondary databases. The secondary database would include data related to bank accounts, credit and saving deposits obtained from the Reserve bank of India and other commercial banks. The primary data will collected through the survey of individuals aged between 15 to 23 years.

This research would employ mixed method (both qualitative and quantitative research design) to investigate the objectives of the study. The qualitative dimension would be employed to understand the financial decision making. The quantitative dimension would be used to construct the composite index of financial inclusion in order to identify the best and the worst performing State. The composite index will be used to describe the pattern of inter regional disparities in the financial inclusion. Thereafter, an attempt would be made to assess the relationship between financial inclusion and financial capabilities and identify factors determining individual financial capabilities. The financial capability index would be drawn from data collected through interview cum questionnaire method based on primary sample survey of two select districts.

The purposive stratified random sampling technique will be applied to select the sample of individuals aged between 15 to 23 years. The sample of the individuals will be grouped according to their educational level; secondary, higher secondary and higher education. The geographic location of the primary survey will be decided based on the composite index of financial inclusion. One district from state with highest index value and one district from the

state with the lowest index value will be selected. The data collection site would be university or college in the selected geographical location.

# Sample Size Determination

In determining the sample size for this study, the following formula will be adopted from (deVaus2002), Based on assumption; 95% confidence level, 5% margin of error and estimated heterogeneity of the population to be 20%.

Where n is the minimum sample size required

p% is the proportion belonging to the special category


q% is the proportion not belonging to the specialcategory

z is the z value belonging to the level of the confidence level required, and e% is the margin of error.

Based on the minimum sample size of 245, the adjusted sample size can be obtained as  $n' = n/\{1+(n/N)\}$ .

Factor analysis will be used to construct the composite indices of both financial inclusion and financial capabilities.. To identify the factors determining financial capability multivariate regression analysis will be carried out.
