The EPIP association will hold its 3rd Annual Conference on October 3rd and 4th, 2008 in Bern (Switzerland). Scholars and practitioners interested in the economic, legal and management aspects of intellectual property rights are encouraged to attend the conference with or without paper presentation.

As for the previous conferences (2006 in München and 2007 in Lund), the 2008 EPIP Annual Conference will address topics of general interest in the area of IPR, such as:

- National and European legal regime's evolution
- Incentives and organisation of patent offices
- IPR litigation and enforcement
- University patenting
- Patents in new technological fields
- The governance of IPR systems
- The impact of IPR on competition and innovation
- The new methods and tool for the management of intellectual assets.

Because of the close geographical proximity of the conference location to WIPO, WTO, WHO and UNCTAD (all based in Geneva), emphasis will be given to the challenges encountered by developing countries in the context of the TRIPS (trade related aspects of intellectual property rights) regime. Empirical and theoretical papers on innovation capacity, technology transfer and access to knowledge in developing countries as well as the impact of TRIPS will be particularly welcome. Country case studies on the building of IPR institutions (cost, benefits, procedures).

The following guidelines must be followed when submitting an abstract:

- Format: PDF
- Length: 2 A4 pages, single-spaced
- The abstract must include:
 - o the title of the paper
 - o the name(s), affiliation(s) and academic position(s) of the author(s)

The abstracts will be selected by the Scientific Committee using the criteria of scientific excellence.
