Continuing the work begun in *The Changing Roles of Debt and Equity in Financing U.S. Capital Formation*, this volume brings new, long-term empirical analysis to bear on vital questions of corporate finance and macroeconomic development. The result is an indispensable resource not only for academics interested in the financial structure of U.S. corporations and the relationship of corporate capital needs to those of government, but for the firms and individuals who make decisions on financing corporate investment.

BENJAMIN M. FRIEDMAN is professor of economics at Harvard University and program director for financial markets and monetary economics at the National Bureau of Economic Research. He is also the editor of *The Changing Roles of Debt and Equity in Financing U.S. Capital Formation*, published by the University of Chicago Press.
