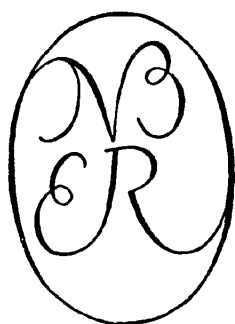

## *Relation of the Directors to the Work and Publications of the National Bureau of Economic Research*

1. The object of the National Bureau of Economic Research is to ascertain and to present to the public important economic facts and their interpretation in a scientific and impartial manner. The Board of Directors is charged with the responsibility of ensuring that the work of the National Bureau is carried on in strict conformity with this object.

2. To this end the Board of Directors shall appoint one or more Directors of Research.

3. The Director or Directors of Research shall submit to the members of the Board, or to its Executive Committee, for their formal adoption, all specific proposals concerning researches to be instituted.

4. No report shall be published until the Director or Directors of Research shall have submitted to the Board a summary drawing attention to the character of the data and their utilization in the report, the nature and treatment of the problems involved, the main conclusions, and such other information as in their opinion would serve to determine the suitability of the report for publication in accordance with the principles of the National Bureau.

5. A copy of any manuscript proposed for publication shall also be submitted to each member of the Board. For each manuscript to be so submitted a special committee shall be appointed by the President, or at his designation by the Executive Director, consisting of three Directors selected as nearly as may be one from each general division of the Board. The names of the special manuscript committee shall be stated to each Director when the summary and report described in paragraph (4) are sent to him. It shall be the duty of each

member of the committee to read the manuscript. If each member of the special committee signifies his approval within thirty days, the manuscript may be published. If each member of the special committee has not signified his approval within thirty days of the transmittal of the report and manuscript, the Director of Research shall then notify each member of the Board, requesting approval or disapproval of publication, and thirty additional days shall be granted for this purpose. The manuscript shall then not be published unless at least a majority of the entire Board and a two-thirds majority of those members of the Board who shall have voted on the proposal within the time fixed for the receipt of votes on the publication proposed shall have approved.

6. No manuscript may be published, though approved by each member of the special committee, until forty-five days have elapsed from the transmittal of the summary and report. The interval is allowed for the receipt of any memorandum of dissent or reservation, together with a brief statement of his reasons, that any member may wish to express; and such memorandum of dissent or reservation shall be published with the manuscript if he so desires. Publication does not, however, imply that each member of the Board has read the manuscript, or that either members of the Board in general, or of the special committee, have passed upon its validity in every detail.

7. A copy of this resolution shall, unless otherwise determined by the Board, be printed in each copy of every National Bureau book.

## *Introduction*

The National Bureau, in the course of several decades of research, has collected and analyzed hundreds of monthly, quarterly, and annual time series relating to almost every aspect of economic activity. These series, compiled with great care, checked, annotated, and seasonally adjusted in the course of various Bureau studies, represent a large investment. This is particularly true of the monthly and quarterly data. The Bureau has often been asked to draw on this valuable resource for the benefit of economists in business firms, government agencies, universities, and other institutions. Because the data are not in published form, the National Bureau has not been able to satisfy all the requests for assistance.

This source book, a compilation of the principal time series on construction in the United States, is a first step towards making the National Bureau's data collection available to the public in convenient form. The Bureau's series, which form the main basis of the source book, have been brought up to date and revised, where necessary. Furthermore, many series not previously collected by the Bureau have been added for completeness of coverage. Source notes have been provided for every series, and certain analytical measures for some of them.

We attempt to cover construction expenditures, contracts, permits, and starts fairly completely and to give a sampling of the main series on construction materials. Only national totals are included, except in cases where data for a particular activity exist only for a smaller area during a period. Where

regional breakdowns are given in the source they are mentioned in the notes to series. The original plan and list of series for the source book envisaged covering all fixed investment, including series on machinery and equipment investment and on total investment (construction and equipment) but time did not permit completion of that whole area. However, the existence of some series on total investment is pointed out in the notes.

No source book of this type could possibly be complete, but an effort was made to include the major series in each area. In choosing series to be included, preference was given to longer series and to data for earlier periods rather than the more readily available information for recent years. Where a series had been clearly superseded by another produced by the same agency (as was the case with successive revisions of the U.S. Department of Commerce estimates of construction put in place) we have included only the latest version. However, earlier versions of the Commerce estimates are imbedded in other series, such as those of Kuznets and Goldsmith. These partly obsolete series have been shown if the superseded data are necessary for comparability with earlier parts of the series.

We have excluded from our compilation certain very crude estimates, such as extrapolations based on assumed trends or fixed relationships to population or income, which we judged were constructed for purposes that did not require even rough accuracy in annual or even decadal movements. However, the existence of these has been noted whenever we were aware of them.

The source book is divided into four sections. Section I is the list of series and page references. It shows the pages in this volume on which the monthly and quarterly data, the annual data, and the source notes appear. The data themselves, in Section II, are divided into a monthly and quarterly section, including both original and seasonally adjusted series, and an annual section. Section III contains source notes and a description of the compilation of each series, and Section IV includes cyclical measures for selected series and a brief description of these measures.

The annual data in Section II are arranged by subjects. The monthly and quarterly data, however, are partly arranged by source to save space in printing. As a result, it will be necessary to use the list of series in Section I to find particular ones. For some series the data have been published in segments at different levels, with overlaps of a year or more. We have generally reproduced these series as published, but the seasonally adjusted data have sometimes, for convenience, been linked and placed on a single level, usually that of the latest segment. In most cases, however, the seasonally adjusted data have been put on the same level as the unadjusted.

The notes in Section III are also, in some cases, arranged by source rather than subject, particularly where many series were taken

from a single source. It was convenient to write a general note describing the characteristics of a source and to follow this with descriptions of all the series based on that source.

We have attempted, in these notes to each series, to be very specific about sources. The series descriptions are less complete, however, and fall short of providing the information needed to reproduce the series. They aim, instead, at giving the user an idea of the nature and quality of the particular series, the method of construction in general terms but not in detail. The notes are thus guides to further investigation of the series but do not attempt to provide definitive descriptions of them.

The original plan for the source book was to cover only monthly and quarterly series in order to meet the needs of those interested in business cycle research. Upon further consideration we decided that it would be useful to include annual series as well, in order to make the compilation useful to those interested in economic growth and other topics, and to extend the length of the period covered.

This book is, to a considerable extent, an experiment to determine whether the publication of these data in this form will meet an important need. If so, it may be worthwhile to extend the work to cover other areas of economic activity.
