His principal interest is in the modeling of commodity markets, including oils and fats, wheat, jute, wines, steel, coal, tin, bauxite and copper. Major publications in this area include several books: Speculation, Hedging and Commodity Price Forecasts (with C.W.J. Granger); Dynamic Commodity Models: Specification, Estimation and Simulation; Quantitative Models of Commodity Markets; and Market Structure, Bargaining Power and Resource Price Formation. His research interests include the role of commodities in trade and development, commodity futures markets, commodity market structure, and commodity price forecasting. Dr. Labys received the B.S. in engineering from Carnegie-Mellon, the M.B.A. from Duquesne, the M.A. in economics from Harvard, and the Ph.D. in economics from the University of Nottingham in England.

Professor M. Ishaq Nadiri is presently Jay Gould Professor of Economics at New York University, where he served as Chairman of the Economics Department from 1972–1978. Dr. Nadiri is also a staff member of the National Bureau of Economic Research in New York City. He has written many articles in the areas of demand for investment, theory of productivity, demand for money and labor, and price formation. Along with Sherwin Rosen, he co-authored the book A Disequilibrium Model of Demand for Factors of Production. He has also edited several books on various areas of economics.

José F. Nuñez del Arco is a senior economist at the Inter-American Development Bank. He has combined an academic career with exten-
