APPENDIX F

INDEXES FROM WHOLESALE PRICES AND RELATED DATA

General Note

This appendix contains price indexes and indexes of U.S. price competitiveness computed from domestic wholesale price series for SITC 2-digit commodity divisions, 3-digit groups, and 4-digit subgroups. The foreign countries included in this appendix are the United Kingdom, Germany, France, and Japan. There were insufficient data for the computation of indexes for the EEC. Some additional series on German producers' prices are shown, in addition to the wholesale price data.

The indexes were collected in as great a commodity detail as possible, and each series was classified by the SITC coding system. The SITC groups and subgroups listed are all those for which wholesale price series are available, even if only a single commodity is covered.

The foreign wholesale price indexes are, in most cases, annual averages for the years 1953, 1957, 1961, and 1962, and midyears for 1963 and 1964. U.S. wholesale price indexes are midyears (June–July averages) for all the years included. For all the indexes, 1962 equals 100. Changes in German prices between 1957 and 1961 were adjusted to take account of a 5 per cent appreciation of the German mark, and French price series were adjusted for the 29 per cent depreciation of the French franc in 1961.

For each country the 4-digit wholesale price indexes, when available, were aggregated to 3-digit averages, and then to 2-digit averages, using international trade weights. The indexes of U.S. price competitiveness computed from wholesale price indexes were calculated at the most detailed level available and aggregated using international weights.

Germany: *Statistisches Jahrbuch für die Bundesrepublik Deutschland*, 1959 and 1963, Section XX, Table V; and correspondence with IFO Institute.

France: *Bulletin Mensuel de Statistique*, Institut National de la Statistique et des Études Économiques, various issues; and correspondence with the Institut National.

Japan: *Wholesale Price Index Annual*, Statistics Department, Bank of Japan.
