**RELATION OF THE DIRECTORS
TO THE WORK AND PUBLICATIONS
OF THE NATIONAL BUREAU OF ECONOMIC RESEARCH**

1. The object of the National Bureau of Economic Research is to ascertain and to present to the public important economic facts and their interpretation in a scientific and impartial manner. The Board of Directors is charged with the responsibility of ensuring that the work of the National Bureau is carried on in strict conformity with this object.
2. To this end the Board of Directors shall appoint one or more Directors of Research.
3. The Director or Directors of Research shall submit to the members of the Board, or to its Executive Committee, for their formal adoption, all specific proposals for work to be instituted.
4. No report shall be published until the Director or Directors of Research shall have ascertained that the Board of Directors is in agreement to the character of the plan, and the utilization in the summary, the nature and treatment of the material, and the character of the scientific information as in their opinion valuable to the public, and the suitability of the report for publication in accordance with the principles of the National Bureau.
5. A copy of any manuscript proposed for publication shall also be submitted to each member of the Board. For each manuscript to be so submitted a special committee shall be appointed by the President, or at his designation by the Executive Committee, composed of three or more members, nearly as may be appointed, to examine the manuscript, and on the terms of the special manuscript committee report to the Board of Directors. When the summary and report describing the manuscript are sent to him, it shall be the duty of each member of the committee to read the manuscript. If each member of the special committee is able to appear within thirty days, the manuscript may be published, though a majority of the special committee has not signified his approval, or reservation of opinion, on the report and manuscript; the Director or Directors shall then notify each member of the Board, requesting approval or disapproval of publication, and thirty additional days shall be granted for this purpose. The manuscript shall not be published unless such approval of publication by the Board had a two-thirds majority of those members of the Board who shall have voted on the proposal within the time fixed for their reply, or unless the resolution proposed shall have approved.
6. No manuscript may be published, though approved by each member of the special committee, until approval has been received from the transmittal of the summary and report. The report shall follow after the receipt of any memorandum of dissent or reservation of opinion, with a full statement of his reasons, that any member may desire to present, and such memorandum of dissent or reservation shall be printed in the manuscript, if he so desires. Publication does not, however, bind any member of the Board who has read the manuscript, or that either members of the Board in general, or of the special committee, have passed upon its validity in every detail.
7. A copy of this resolution shall, unless otherwise determined by the Board, be printed in each copy of every National Bureau book.
